The total cost of sales was \$7,511.09, resulting in a gross profit of \$1,914.56. Total operating expenses were \$3,676.05, leaving an operating loss of (\$1,761.49). Interest income was \$54.98, resulting in a net loss of (\$1,706.51). Total assets as of September 30, 2023, from checking/savings/other equaled \$153,661.
