Old BUSINESS—-20 Minutes

Using KBDM (Knowledge-Based Decision Making) to reach an Orange County/Greater Long Beach Intergroup decision on the question of whether Intergroup and Service Board meetings will remain on Zoom or be in person. Thanks to Lauren H. for preparing

the KBDM framing document. Our Service Manual advises in Warranty Three "That all important decisions be reached by discussion, vote and whenever possible by substantial majority." Can we agree that this decision requires a 2/3 majority? Please raise the virtual hand under the Reactions button at the bottom of your screen to agree that we will require a 2/3 majority vote in order to arrive at a decision.

Knowledge Based Decision Making Framing Document:

Topic for discussion: Returning to in-person Intergroup Meetings

 The Intergroup Meeting considers returning in person or continuing to meet on Zoom as we move forward into 2022.

Background Information:

- Up until the COVID Pandemic, the Intergroup and Service Board meetings were held in the evenings at Trinity Episcopal Church in Orange on the third Wednesday of each month with the exception for the month of December.
- There was a monthly fee of \$100 to hold a 2-hour meeting for the Intergroup meeting and Service Board meeting.
- The annual cost is \$199.90 to hold both meetings on Zoom.
- Orange County Intergroup and Service Board meetings were held in Orange because it was equidistant from the ends of our boundaries: La Habra to the north, San Clemente to the south, and the Greater Long Beach area to the west.

Explore the Issue:

What we know:

- We know our members are in a widely scattered geographic area and some travel a great distance (as far as La Habra, Long Beach, and San Clemente) to attend an in-person Intergroup or Service Board meeting.
- Annual Zoom fees are \$199.90 for Intergroup and Service Board
- Holding in-person meetings at Trinity Episcopal Church would be \$100 per month (\$1200 annually) if the rate is not increased.
- Some ISRs and Board members are ready to return to inperson meetings, and some are not ready or able to return in-person.
- Intergroup meetings that were held in person have a different dynamic than meetings currently held on Zoom.
- 7th Tradition collections were greater when we "passed the basket" at an in-person meeting.
- Business of the Intergroup and Service Board will be conducted regardless of the location of the meeting (inperson or on Zoom).

What we don't know:

 We do not know if members prefer to meet in person or on Zoom.

There is also a lot we do not know about the new Omicron variant. According to the CDC's Science Brief: Omicron (B.1.1.529) Variant updated on Dec. 2, 2021, "...it is unknown how efficiently the Omicron variant can spread from person to person..." and "...it is unclear if infection with the Omicron variant is associated with more severe disease...":

NEW BUSINESS—-Introducing Proposed Bylaws Change

As required by our Bylaws, Intergroup Service Representatives received written notice of this proposed bylaws change in the December 1, 2021, announcement of tonight's meeting. To meet bylaws requirements that Information Service Representatives receive written notice at least four weeks before a vote is scheduled, we will not vote on this proposed change until the February meeting. The notice reads:

"Also, at this meeting we are *introducing* a proposal that the word "salaried" be dropped from references in our manuals to the requirement that the office be staffed during business hours by a salaried employee and that volunteers not be on duty without the presence of a salaried employee. At one time, part-time employees may have met the definition of salaried in the labor code. Today, the term "salaried" suggests full-time employment. This not only affects vacation and sick time coverage, but also the suggestion many members have made that having part-time employees would minimize disruption when there are staffing changes."
