#### Alateen

Alateen Workshop May 14, 2011

Had three speakers who are Alateen and they shared how Alateen has changed their life and made them become better people. It has given the unconditional love and support to deal with the disease of alcoholism

They had three sponsors talk about the joys of being an Alateen sponsor. They had one preteen sponsor talk about how she works with little children to instill as much program as she can in them. The preteen meetings are like adult meetings, but they do more activities, and role playing.

Chris C. and Anita from world service spoke about starting a meeting and the need for more meetings in Orange County area.

Alateen concerns:

Find ways to close the gap between Alateen and Alanon.

They said that approximately 80% of Alanon and AA parents do not take their children to Alateen or preteen. Possible reasons are misconceptions, or not really understanding the need for their children to get the same help that their parents are getting. What ways can we get Alanon's to get their children involved with Alateen?

Not enough Alateen meetings. Alateens have to travel long distances to get to a meeting often with no parental support. There are areas with no Alateen meetings, and many Alateens do not have a meeting to go to. What can we do to help Orange county meetings expand?

Kids who start Alateen find recovery sooner either Alanon and AA.

Lastly, in Southern California there are 600 registered Alanons to help with Alateens, but very few meetings and Alateens sponsors. What ways can we help with more meetings in Alateen?

SCAC had a fantastic last chance picnic this past month and all the Alateens are looking forward to SCAC.
