



Greetings,

H & I has some exciting news. We have established a new email address that allows our fellowship to connect with our committee directly. It also allows us to send out updates of upcoming activities and possible volunteer opportunities to interested members.

Another aspect of change to note is Cianna has created a new form for Intergroup reps to take back to their meetings. This will allow those interested to sign up with their email to receive H & I information electronically. We are attempting to keep up with the information technology and find that our ability to send out emails would be more systematic for the future of the H & I committee.

OC Al-Anon Central office maintains a list of recovery and in-patient and outpatient facilities in Orange County serving the needs of those affected by alcohol and other dependencies and dysfunctions. H & I Committee members are in the process of updating all contact information for the more than 15 such centers now in our files. For example Hoag Hospital in Irvine has an Outpatient Chemical Dependency program four nights a week, including a family night on Friday evenings. On occasion Al- Anon panels are invited to speak to the families to share the importance of Al-Anon and Twelve Step programs.

Alateen Update

(AMIAS = Al-Anon Member Involved in Alateen Service)

Alateen Meetings in OC Juvenile Hall:

- San Diego Al-Anon & Alateen currently has seven individual weekly Alateen meetings in Juvenile Hall facilities.
- On January 6, 2014 four current AMIASs attended a Volunteer Information Meeting for the Orange County Probation Department, the first of several steps in the process to be approved as a *Volunteer In Probation*.
- This will allow us to create ongoing, weekly Alateen meetings within units of the OC Juvenile Hall facilities. To achieve this we will need at least two AMIASs per meeting.
- Interested?: Must first be a current SCWS AMIAS & maintain annual recertification.
- OC Probation Minumum Volunteer Requirements:
 - 1. Attend a volunteer information meeting
 - 2. Be a U.S. citizen or legal U.S. Resident
 - 3. Posses a valid social security card
 - 4. Posses a valid driver's license or California Identification Card
 - 5. Current car insurance coverage or sign form stating no car ownership
 - 6. Annual T.B. test certification
 - 7. Pass a background investigation
- Besides the Volunteer Information Meeting, there are two interviews: an initial interview and a second interview with the background investigation unit.
- Future dates for Volunteer Information Meetings are Mar 5th, May 6th, June 9th, July 17th, Nov 5th, and Dec 1st.
- Application process time period is three months on average.



Forwarding the Al-Anon Central Office phone to your phone:

At the beginning of your shift you will transfer the office phone to the number of your choice as follows:

- 1. Go to dmrcom.com
- 2. Click on the My Account tab (4th tab to the right)
- 3. Click on the **Manage Your Number** heading (The first box on the page.) This will take you to a "log in" page.
- Log in as follows: Number: (Enter the Al-Anon office business number) 7147481113 [no dashes]
 Password: welcome [lower case only]
- 5. This will take you to the Al-Anon Alateen Information page. You should see a "Settings" box in the lower right-hand corner of the page. (If you do not see this "settings" box, click on the Dashboard tab on the top of the page.)
- 6. Click on the "Forward to:" line. This will take you to an entry screen for your phone number. You should see the heading "Immediately | Forwarding Destinations" at the top of the area where you enter your phone number.
- 7. Click the box labeled "Forward calls immediately".
- 8. Enter your phone number in the following format: 1 (949) 555-1212
- 9. Finally click "Apply" button at the bottom of the page. The office phone has now been transferred to *your* phone. You close your browser at this point.

Cancelling Phone Forwarding;

When your shift is over you need to cancel the phone forwarding. You do this by following steps 1 through 5 above. Un-check the "Forward calls immediately" box and click the "Apply" button at the bottom of the page. Once you have clicked the "Apply" button you can just close your browser.

Answering the phone:

If you want to preserve your anonymity, you can answer "Hello" or "Hello, this is (first name.)" If the caller wants Al-Anon they'll either ask or you can tell. Most callers are looking for meeting information so have a directory handy, or print out the directory from

You can also refer them to the website. Sometimes callers confuse us with AA. If they are looking for the AA office refer them to AA's OC Central Office @ 714-556-4555 or 949-582-2697. Other services call 211.

Some callers want to know about Al-Anon; how it works, does it cost anything, etc. Or they want to talk about their situation. Share your experience, strength and hope, but remember, the most important thing is

to get them to go to a meeting. Occasionally people are in a very tough place. If you ever feel it is in their best interest, suggest they call 911.




