Office Coordinator- Julia T. See report. Limited time sale on 3 books until December 31<sup>st</sup>. WSO is asking us to participate in the 2018 Al-Anon membership survey. The office will be closed November 23<sup>rd</sup> and 24<sup>th</sup> in observance of Thanksgiving.

Chair – Diane M. See report. Jayme C., former WSO Delegate, has been asked to address issues of meetings not adhering to Al-Anon traditions. ISR's are asked to encourage meetings to adhere to traditions of the program.

Chair-Elect – Tannis S. See report. Thanks to all the new ISR's who showed up for orientation tonight. People willing to setup and tear-down IR meetings are needed and welcomed.

Ex-Officio – Cianna C. Service office fund-raiser was a huge success. We raised \$527 for the office, after expenses.

Special Report: WSO Past Delegate – Jayme C. Changes to portions of the Service Manual were made by WSO this year (see handout). Dual members are not eligible to serve beyond the group level, wherever voting is to be carried out (this applies to Intergroup representative positions). CAL

pamphlets can be useful in assisting group members for sticking to the Al-Anon focus when sharing in meetings. Groups should read from *Al-Anon Groups at Work* instead of copying or typing readings for meetings. Also, consider encouraging the groups to carry literature in other languages to accommodate other ethnic groups.

ISR's are encouraged to ask your groups if they would like to donate Alateen literature to schools.
