1. Financial Challenges Continue

- Intergroup had a \$12,735 net loss over 9 months (Avg. \$1,400 per month)
- Cash balance down 17.4% vs. last March
- \$5,000 moved from reserve to checking to support operations

2. Less Money Coming In and More Going Out (9 months July - March)

- Contributions down 6% vs. same time last year (about \$3,000)
- Literature sales down 10.4% (about \$3,800)
- Office Operating expenses up 13.3% (about \$6,000)

Pam suggested an online store rather than coming into the office in person and suggested a smaller office space.

Discussion: If folks are using square they do not need to enter their WSO number if they don't know it. They can just enter one character to move forward with the donation, the group will not get credit for the donation without the WSO number.

Secretary (Lisa N.)

District 57 has 36 registered groups and 19 registered ISR's.
District 60 has 34 registered groups and 26 registered ISR's.
District 63 has 29 registered groups and 16 registered ISR's.
District 66 has 72 registered groups and 36 registered ISR's.

Review of the bylaws reveal only 15% of registered ISR's need to be present to make a quorum.

Quorum: We have (97) registered ISR's, 15% (15) need to be present to make a quorum. A majority of the Intergroup Representatives were present to satisfy the quorum.

New Business

Nominations/Historian (Nikki):

One person was nominated to run for Service Board and has since declined the nomination. There are no nominees at this time.

Nikki provided a presentation on the mandates of the bylaws and where we are currently with the service board.

Discussion with the ISR's about how to move forward without any nominees. If motions are made regarding how to move forward we will be voting on such.

Group Discussion:

Lolita suggested the board has taken a survey to find out what people have not stepped up for service.

David asked if we could lower the requirement of the number of officers and board members.

Nikki-we could do a special election with the following timelines:

April 15-May 1 nominations, May 6 send out ballot, May 7-June 16 voting, June 17 Special Election where ISR cast their vote.

Nikki mentioned she has been at recent meetings and the letter she sent and the flyer were not shared. Question...are ISR's reading the letter and sharing the flyer?

Suggestion: Ask by raise of hand at the meeting who is able to serve and has the one year of ISR experience.

If ISR was a two year commitment ~~more ISRs in the room would be available to be nominated to the service board.~~

Alexandria made a motion to hold ~~a special election.~~ Verna seconded the motion. Motion passed 44 yea's

We continue to maintain a list of people who are available for panels and add to the list when needed.

We monitor existing panels and find replacements for those coming off of commitments. Our main time is spent liasoning with SCWS Institutions rep, interviewing and processing the eight Alanon volunteers' paperwork which is required for security and Covid protocols for the four jail meetings. We have approval by the jails for the meetings. We are waiting on room assignments, times and dates of meetings and orientation procedure. We still need more volunteers in case this process continues to be lengthy or we lose volunteers for other reasons. We will be placing another flyer in the Orange Blossom.

My two years on the board is complete in July 2026. Thank you for letting me serve.
