Old/Unfinished Business: Consider addressing weekend phone coverage, or lack thereof. Motion by DJ to spend \$1700 on Square credit card hardware for the service office. Seconded by Marque. Motion passed unanimously.

New Business: Andy from SoCal World Service gave some points of discussion on public outreach to include crossover between intergroup and world service structures. Consideration of being aware of issues and hurdles with generating interest in being of service. Fidelity bonds are up for consideration. Date for the Office Anniversary has been changed to September 21<sup>st,</sup> 2019.
