REPORTS:

Quorum: With 48 groups represented at the start of the meeting, attendance exceeded the requirement that 15% of our 82 registered ISRs (12.3 ISRs) be present to constitute a quorum.

<u>Secretary</u> – Chip G. – The minutes of June 15, 2022 were reviewed and upon motion made by Cindy R. and seconded by Jonny Q. were approved as presented.

Decision: Ayes = 37, Nays = zero, and Abstentions = zero. **Motion carried**.

There were no motions made at the July 20, 2022 Service Board meeting.

<u>Treasurer</u> – Sam M. - see report appended to these minutes. Monthly reports are linked under calendar of events on the website. As of August 17, 2022, the total Service Office income was \$6,728 from various contributions. Total Service Office expenses were \$6,675, comprised of payroll, literature, rent and other office expenses, producing a net income for the month of \$53.00. Total assets from checking/savings/other equal \$144,251.74, a change from the previous month of -\$1,307.86.

<u>Chairperson</u> – Sarah G. thanked the outgoing and incoming Service Board members. She stated that there are still open positions on the board and welcomes volunteers. Sarah reported that the Los Alamitos Fundraiser made over \$2,300 in contributions. Fundraising will be one of our new focuses.

Oversight & Continuity Committee: - Julie S. reported that the Office Oversight & Continuity Committee is helping the new Member Services Representatives, Sam C. and Mike F. transition in their new roles. They are working with the committee to incorporate the World Service registration system in ours. The committee is also reviewing and making recommendations for revisions to the group manual. They are committed to increasing assets after Covid so office hours can be increased.
