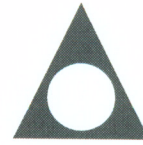


Question" Can AA members be AMIAS (Alateen) sponsors? Yes, per previous discussion but it is based on their Al-Anon membership.
