Six month trial period with the new format has been completed. Committee received a question about why we are using Al-Anon's money to pay postage for the Orange Blossom mailing. Al-Anon pays \$200 per year for a bulk rate permit which allows us to mail at much lower rates. We need to increase subscriptions of the OB. We currently send out about 400 per month, but not all are paid subscriptions. As IRs, you receive one for your group. Please consider purchasing a subscription to give to a friend, sponsee or a newcomer at your meeting. Also, remember to re-subscribe once your subscription expires. We only charge \$7.50 per year; other counties charge more. We are still looking at other options for distribution.

How does a meeting register?

- Al-Anon Groups are registered with the World Service Office through the Southern California World Service Area group records coordinator, who uses a form entitled "Group Registration/Records Change Form." The form can be filled out online for faster processing, or it can be printed out, filled in and mailed to the address on the bottom of the form. The form can be accessed in two ways: (1) via the SCWS Web site at http://scws-al-anon.org/send\_mtg\_record\_updates.php or (2) via a link on the Orange County Intergroup Web site, which also includes a form with which to register for inclusion in the Intergroup Meeting Directory and Web site listing of meetings.
- To access the form(s) on the Intergroup Web site, go to orangecountyalanon.org. In the list of words in orange letters on the left side of the screen, click on "Intergroup." Under the heading, "Group Officer Forms," go to the third paragraph and click on the underlined word "form" at the end of the last line.
- To register for an Orange County Meeting Directory listing, go to the second paragraph under the "Group Officer Forms" heading and click on the words "this form" to fill out and send information online, or click on the words "clicking here" to print out a form you can mail in.
