Written report attached. Carol G. absent. Mary Lou reported. Question: regarding dual membership and service beyond the group level, if someone is no longer a member of the other program, why are they still not allowed to be of service at the IR level? Answer: We have to follow the Service Manual on this subject. See page 126 of the revised Service Manual – it covers the dual membership issue. If you need more information, please contact Julie S. Question: From the written report, under "Studies in Progress", what are they talking about "the Spanish overlay district, groups that do not consider Al-Anon as a whole" (these two items are different, distinct subjects)? Answer: Cathleen C., ex-SB member who was at the WSO meeting said the Spanish overlay district, designed as a temporary 3-yr fix (20 years ago), is being studied again. Question: the IR clarified that her real question was related to "groups that do not consider Al-Anon as a whole". Answer: The Area has a task force that is tasked with coming up with solutions for meetings that do not follow the Al-Anon traditions. They will make a determination of appropriate actions to take, and whatever their determination is, the OC Intergroup will need to make sure our actions are in compliance with the Area's.

- Offer a free printable version of the Orange Blossom online for a trial period of one year to see if paid subscriptions decline. Continue to offer the printed hard copy version for one year for \$10.00 annual subscription price as of June 1st with the possible consequence that it might be eliminated at the end of the trial period.
- 2. Continue to publish the printed hard copy version of the Orange Blossom for a \$10.00 annual subscription price which would include a printable version online at no additional charge to be paid subscribers only. Also, make the online printable version of the Orange Blossom available for a \$5.00 annual subscription to those not wanting a hard copy version. For non-subscribers, offer a free read-only version of the Orange Blossom.
