MINUTES OF THE SERVICE BOARD MEETING November 18, 2015

Julie S. (Chair) called meeting to order with the Serenity Prayer at 7:04 pm Twelve Traditions read by Wendy M.

Motion: By Wendy M. – to accept minutes from September 16, 2015 Service Board Meeting as presented. 2nd by Bill P. 9 in favor/none opposed. The motion carried.

Treasurer – Julie S. reported for Ada G. (absent)

Julie provided the Financial Report for October. Mary Lou L. presented information on AFG financial guidelines that pertain to group reserve funds and how they are distributed. After discussion, it was decided to provide educational material regarding finances to IRs at each meeting that they could present to their group. The purpose is to educate groups about where their contributions go and how they are used, and assisting them with AFG information that will help them to make sound financial decisions. Mary Lou to summarize information to be provided to IRs. Passed basket for 7th Tradition.

This evolved into a conversation about how the board communicates with IRs, and how to get information to the groups. The decision was made to 1) create a handout for the IR meeting of suggested topics for IRs to communicate at each meeting between IR meetings, 2) to remind/invite IRs to attend an Orientation, conveying that Orientation is a requirement rather than an option, and 3) use the IR email list to email reports to IRs right after IR meetings. Motion was made by Brandi S. to upgrade to a new health insurance carrier with better coverage for the office coordinator, which includes a \$90 increase per month from the current amount.
