Discussion followed. **Motion** by Geri M. to approve up to \$5000 for legal fees for review of operational procedures and bylaws of the organization. Seconded by Matt St.M. **Carried. No- 1 vote.**

(not present)- Ginger reported that she is in conversations with her contact for CA City Correctional in regard to sharing and distributing Al-Anon information.
